2004 Company headquarters relocated to Bönen and the new, modern production facility set up.

2005 Wholesale authorisation in accordance with § 52a (1) AMG.

2006 Relocation of the laboratory to the new premises with cleanroom class D.

2008 Founding of QHP Life Science GmbH as an independent test laboratory with a focus on product analytics.

2010 Spin-off of the test laboratory into a separate company (QHP Pharma Analytics GmbH.

2010 Spin-off of the sales department into a separate company.

2011 Founding of an import and distribution company for pharmacy distribution of high-quality nutritional supplements and OTC products in Istanbul, Turkey.

2013 Founding of a company for distribution of high-quality nutritional supplements and OTC products in Eastern European countries.

2014 Founding of a company for development and distribution of private label nutritional supplements in England.

2020 Renaming of the distribution company to Euro OTC & Audor Pharma GmbH.

This may help people who cannot take oral medicines. such as groups of people who have difficulties swallowing. Furthermore, hormones can be administered in lower doses, which is a great advantage in the therapy of menopause-related, thyroid, and other hormonal problems.

Use of smaller amounts of hormones reduces side effects. In addition to this liposome concept, the company also has developed dedicated gels and creams with unique compositions that form the basis for formulations and prescriptions by doctors and pharmacists in the field of hormone therapy. The fields of dermatics and anti-aging care are pioneering areas. After all, everyone wants to age healthily - on the outside and inside alike. The potential for developing new products is great and it keeps on growing. The same basics can, of course, also be used for non-hormones, other indications and areas of application.


