FAQ

→ Who is the seller? Is Seedea the seller?

No. Seedea acts as a broker connecting buyers with suppliers of bulk food ingredients. You purchase directly from the supplier; the invoicing party is the direct seller.

→ Are your suppliers GFSI-certified?

Yes. Almost all of our suppliers hold GFSI certifications such as FSSC 22000, IFS, or BRC.

→ Who arranges the shipment?

Shipments are scheduled according to the buyer's timeline. Seedea coordinates logistics to ensure smooth and timely deliveries.

→ Who will handle daily communication?

Seedea is your central point of contact for orders, logistics, and certificates—to keep things simple.

→ What are the payment terms?

Payment terms are negotiated between the buyer and the seller as part of the final agreement. Seedea facilitates the process to ensure clarity.

→ How soon will I receive my order after signing the contract?

Typically within 2–3 weeks, depending on the buyer's delivery schedule.

→ What is the minimum order quantity (MOQ)?

Standard MOQ is 12 tons. We can also arrange mixed loads of 2–3 bulk ingredients in a single delivery.
